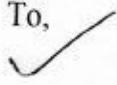

- Schools can sign up multiple teams that include different Classes i.e., IX & X and XI & XII
- Each team manages a portfolio of \$100,000 in virtual cash over the course of 10 weeks using Wharton's Online Trading and Investment Simulator (OTIS)
- Participants should NOT register more than once
- Your registration covers all competition activities; DO NOT register separately on the OTIS
- Be sure to carefully review all the information provided
- Advisors/Teachers, make sure your students/teams have correct email address
- Students, ONLY the Student Team Leader should register his/her team. Team members should NOT register.

**Post Registration:** An intimation is required to be sent to Senior Manager, NAL to take it forward for the coordination with Wharton School and also inform the Board on or before 16<sup>th</sup> September, 2018.

**History:** Wharton school has conducted the investor competition last year in Bangalore.


