
Subject: **Duties of teachers on examination related works.**

NOTIFICATION

NO. EDS/NBSE-05/2009 It is hereby notified for information of all Heads and Teachers under the Government of High Schools and Higher Secondary Schools, it is to inform that the duty of teachers is to comply with examination related works such as paper setting, moderation and evaluation when such duties are entrusted to them. Teachers should note that evaluation/ assessment is a part of the teaching and learning process.

Therefore, it is mandatory on the part of the teachers to perform duties as and when called for. The duties performed by the teachers for such works shall be treated as official duty by the Head of the Institution.

Teachers/ Head of Institutions who fail to comply with the order issued by the competent authority for examination related works shall be treated as dereliction of duty and Departmental action including denial of promotion shall be taken against them.

The Secretary, Nagaland Board of School Education shall make such status report every year to the Government for necessary action.

This is for strict compliance.
